

## MINUTES OF THE TENTH ANNUAL MEETING OF THE PROVINCIAL GRAND SENATUS OF SURREY

## Held at Surbiton Masonic Hall on Thursday 21<sup>st</sup> July 2022 at 11.15 a.m.

The Right Distinguished Provincial Grand Summus entered the Temple in procession accompanied by the Provincial Grand Officers of the Year

- 1. Provincial Grand Senatus was Opened in due Form at 11.15 a.m.
- 2. The Right Dist Provincial Grand Summus was saluted with *SEVEN* under direction of the Provincial Grand Director of Ceremonies

Other Right Distinguished Companions were saluted with *SEVEN* under the direction of the Provincial Grand Director of Ceremonies. R Dist Comp Stephen N White, Provincial Grand Summus for Gloucestershire, Herefordshire and Wiltshire responded.

- 3. The Provincial Grand Episcopus was pleased to report that since our last meeting no Companions have been called to Higher Service.
- 4. The Assistant Grand Director of Ceremonies, Distinguished Companion Geoffrey Kear, entered and announced that the Most Distinguished Companion Ian Stanley Currans, Grand Summus, is without and demanded admission. The Most Distinguished Grand Summus entered accompanied by the Assistant Grand Summus and was welcomed by the Right Distinguished Provincial Grand Summus.

The Most Distinguished Grand Summus was saluted with *ELEVEN* under direction of his Assistant Grand Director of Ceremonies.



- 5. The Provincial Grand Summus welcomed honoured guests of the Province and other Distinguished Companions.
- 6. To confirm the Minutes of last year's meeting of Provincial Grand Senatus held on 18<sup>th</sup> August 2021. The Minutes were proposed for adoption by Dist Comp Nigel Thomson, Deputy Provincial Grand Summus, and seconded by V.Dist Comp Jack Love, Past Assistant Provincial Grand Summus. The Proposition was duly approved.
- 7. To Call the Roll of Provincial Grand Officers.

The Provincial Grand Recorder reported that with the exception of four officers who have all given good reason for their absence all Active Provincial Officers were present.

8. To Call the Roll of Consistories in the Province

The Provincial Grand Recorder called the Roll of Consistories as follows, and the members of each Consistory rose and indicated their presence with a court bow to the East: -

Upon completion of the Roll Call, the Provincial Grand Recorder announced that all Consistories were in attendance and well represented.

9. To Receive the Report of Provincial Grand Recorder

The Provincial Grand Recorder stated that his Report was distributed prior to the meeting and can be found on the Provincial website. The R Dist Provincial Grand Summus thanked the Provincial Recorder for his Report and his work during the year.

10. To Receive the Audited Accounts for the year to 31st December 2021

The Provincial Grand Treasurer stated that the Audited Balance Sheet and Accounts were distributed prior to the meeting and can be found on the Provincial website and he has nothing further to add. The Provincial Grand Summus asked if there were any questions regarding the accounts. As there were no questions, the R Dist Provincial Grand Summus called upon Dist Comp Nigel Thomson, Deputy Provincial Grand Summus, who proposed the Accounts for adoption and Dist Comp Chris Eley, Provincial Grand Recorder, seconded the proposition. The proposition was duly approved, and the Accounts were adopted. The R Dist Provincial Grand Summus thanked the Treasurer and Account Auditors for their endeavours.

11. To Elect a Provincial Grand Treasurer

The R Dist Provincial Grand Summus announced that he had received only one nomination for the post of Provincial Grand Treasurer: - Dist.Comp. David M Willmott

He therefore declared Dist.Comp D Willmott elected Provincial Grand Treasurer for the ensuing year.

12. To Elect the Account Auditors for the year

Dist.Comp. Chris Eley, Provincial Grand Recorder, proposed the following two Companions for election as Account Auditors for the year: -

Dist.Comp. Ian Bloodworth, Provincial GDC Designate, seconded the Proposition, which was put to the members and duly carried.

13. To confirm the amount of Provincial Dues for 2022-23

The Provincial Grand Treasurer announced that Provincial Per Capita Dues for 2022-23 will remain at £6.00 per member.

- 14. The Treasurer announced that the Fees of Honour effective from July 2023 are as shown on the web site
- 15. The R Dist Provincial Grand Summus announced that he was re-appointing Dist.Comp. Nigel Thomson as Deputy Provincial Grand Summus. He presented Dist.Comp. Nigel who was then saluted with *FIVE* under the direction of the Provincial Grand Director of Ceremonies. Dist Comp Nigel responded.

16. The R Dist Provincial Grand Summus announced that he will appoint and invest Dist.Comp. Simon McCarthy as Assistant Provincial Grand Summus.

An escort was formed and Dist.Comp. Simon entered Provincial Grand Senatus, was Presented, Obligated, Invested and Installed as Assistant Provincial Grand Summus of the Provincial Grand Senatus of Surrey.
